## VCI Recognised Qualifications in Veterinary Medicine and Veterinary Nursing

# **General Information**

The only programme of Veterinary Medicine in Ireland is delivered by University College Dublin (UCD).

Recognised Programmes of Veterinary Medicine are delivered in English by Budapest University of Veterinary Science, Hungary, Kosice University, Slovakia, and Warsaw Agricultural University, Poland.

UK programmes of **veterinary medicine** recognised by the Veterinary Council of Ireland which enable access to the Register of Veterinary Practitioner include Bristol University, Edinburgh University, Glasgow University, Liverpool University, Nottingham University, University of Cambridge, University of London and University of Surrey.

There are 5 programmes of **veterinary nursing** delivered in Ireland which enable access to the Register of Veterinary Nurses of the Veterinary Council of Ireland. These include UCD, Dundalk IT, Atlantic Technological University (ATU) (*formerly known as Letterkenny IT*), Technological University of the Shannon (TUS) (*formerly known as Athlone IT*) and St Johns College Cork.

Programmes of Veterinary Medicine are usually delivered over a 5 year period, with programmes of Veterinary Nursing delivery from 2 to 4 years, depending on the programme.

#### Routes of Access to the VCI Register of Veterinary Practitioners

In order to be registered on the Register of Veterinary Practitioners, you must hold a qualification in veterinary medicine that is recognised for the purpose of registration by the Veterinary Council. The below categories of qualifications may be *automatically recognised* by the Veterinary Council for the purpose of registration:

- Qualifications awarded by universities in Ireland that are accredited by the Veterinary Council of Ireland
- ii. Qualifications awarded in EU member States listed in Annex V point 5.4.2 of Directive 2005/36/EC.
- iii. Qualifications awarded by universities that hold full accreditation/approval status with the European Association of Establishments for Veterinary Education (EAEVE)
- iv. Qualifications awarded by universities in the United Kingdom that are accredited by the Royal college of Veterinary Surgeons (RCVS)

- v. Qualifications awarded after 20 September 2007 by universities accredited by the American Veterinary Medicine Association (AVMA), where the applicant can provide evidence of a passing score in the North American Veterinary Licensing Examination (NAVLE)
- vi. Qualifications awarded by universities that hold full accreditation/approval status with the Australasian Veterinary Boards Council (AVBC).

Qualifications in veterinary medicine that are not recognised by the Veterinary Council for the purpose of registration do not entitle a person to be registered to practise veterinary medicine in the State.
