Under Veterinary Council of Ireland (Recognition of Qualifications and Registration of Veterinary Nurses) Regulations 2022 (S.I. No. 281 of 2022), where an applicant for registration has held veterinary nurse registration previously with the Veterinary Council or with any licensing or registration veterinary nurse body ("registration authority"), the application shall include:

- a. Details of all veterinary nurse registrations currently or previously held by the applicant, including, in thecase of an applicant previously registered with the Council, the registration number associated with such registration; and

An applicant for registration shall not be required to include details listed at a or b where they are a new graduate of veterinary nursing and have not carried out practice since his/her qualification was awarded to them.

Under Veterinary Council of Ireland (Recognition of Qualifications and Registration) (Veterinary Nurse) Regulations 2022, an application for registration in the register shall include, where applicable, details of the applicant's professional experience. An applicant may be asked to submit details of their professional experience with their application in the form of a resume or curriculum vitae (CV).

- 2. Please allow up to 10 working days for us to consider your application, if there is a problem with your submissions, or if we require further clarification based on the information you have provided, we will respond to you by email. Note that this may delay your application.
- 3. Once your application has been approved, we will contact you by email with instructions for paying your fee and registering remotely.

\*Note that you are not permitted to practise in Ireland until you have received explicit email confirmation fromthis office that you have been entered onto the Register.

#### \*Notarised Copy

If your degree and transcripts were produced in a language other than English, then you are required to provide notarised translations of these documents in your application for registration. If your original qualification and transcripts were issued by an authority or body outside of Ireland, then you are also required to provide notarised copies of these documents in your application for registration. A notarised document is one that has been certified by a notary public. A notary public is a public officer who serves the public in non-contentious matters usually concerned with foreign or international documents. Documents notarised by a notary public are acceptable for use internationally. A notary public must certify with a seal/apostille the execution in their presence of the authentication of a document. When you meet a notary, you will be required to prove your identity and place of residence. A notary public may only notarise documents in the country where their principal office is located, as appointed, for example in Ireland, a Notary Public is appointed by the Chief Justice of the Supreme Court of Ireland, for a specific geographical location, ie Dublin, Meath, Wicklow etc.
